#### DESCRIPTION OF THE EXCAVATION SITE – Provide a short description of the site's history

<u>DESCRIBE THE PURPOSE OF THE DESTRUCTION / ALTERATION / DAMAGE</u> — (i.e., for academic study, investigation, recovery etc.)

The ground-truthing of 6 potential grave targets identified through Ground Penetrating Radar (GPR) scanning undertaken on Erf 24602 (SU Campus). It is important to note that no exhumation is being proposed, only the ground truthing of 6 potential burial targets. As requested, two community leaders to be identified by the new Hardekraaltjie Memorial Management Committee (HMMC) will be present at the test excavations. The outcome of the ground truthing will determine the way forward in terms of the buffer area around the Hardekraaltjie Cemetery and the proposed Memorialisation thereof.

MOTIVATION FOR PROPOSED ACTION/S – (Provide a brief motivation in terms of heritage grounds and the necessity of the exhumation or rescue of human remain/s)

#### Methodology for ground truthing:

The locations of a number of potential graves on Erf 24602 (SU Campus) were noted using ground penetrating radar. These locations were surveyed, and the surveyor will return to the site prior to the excavation work and mark the six targets. Although many other anomalies were also noted, the six that seemed most likely to be graves were earmarked for testing so that, overall, the amount of disturbance could be minimised. It is assumed that if these six most likely targets prove negative then the remaining less likely targets will also be negative.

Once the targets are pegged by the surveyor, Dr Orton will visit the site and hand excavate small trenches at 90 degrees across the potential targets. The aims will be to look for, in this order:

- (1) disturbance in the soil indicative of a grave shaft,
- (2) brown stains or wood fragments indicating the edges of coffins (the lids cave in and rest on the bones in the base of the coffin, but the full height of the side walls of the coffins is usually preserved), and

#### (3) human remains.

It will probably be best to stop excavation of each target as soon as one of these signs is found. Once all six have been explored we can then go back and work further if necessary. Ground disturbance alone in all 6 targets will not necessarily prove graves. We can also consult with the community leaders on site to determine whether further excavation should be carried out. Seeing coffin remains will guarantee that graves occur, and it can probably be assumed that no exhumations took place. If for any reason there is still doubt, then the last option of continuing till human remains are exposed will be applicable. The deeper the excavation goes, the larger the hole/trench will need to be.

Note that NO exhumation is proposed and the plan will be to affect the minimum amount of disturbance possible in order to gain clarity on whether graves occur in the 'extended buffer zone' on Erf 24602 (SU Campus) or not. Therefore, the ground truthing proposed is only to establish that graves are present and not to move them in any way. At this point we do not know if there are graves, but all the necessary precautionary measures have and will be taken.




