Appendix E16: Confirmation of service provision

1. Electricity

Electricity supply to the proposed development will be provided either through an upgrade of the existing Eskom supply or via supplementary rooftop solar installed on existing buildings. The development requires approximately 60 kVA of additional supply. Eskom is the current Network Service Provider. Eskom confirmed in writing "The existing transformer and meter box is already 200kVa, therefore no work will be done in the field, but it will only be paperwork" This imply that the hardware is in place and that the additional supply is merely paperwork which implies that the extra supply capacity is available. This is further confirmed by the quote letter subsequently supplied by Eskom for the capacity increase (refer Annexure A below). This would provide sufficient additional capacity for the proposed development. Alternatively, the applicant may install rooftop solar panels on existing infrastructure, providing approximately 0.054 MW of additional capacity. This installation would not trigger any NEMA-listed activities and can be implemented immediately if required. Regardless of the electricity supply option ultimately used, new underground step-up/step-down cable with a transmission capacity of 3,3 kV will be installed to the proposed development site. Given this transmission capacity, the supply line does not constitute a NEMA listed activity in its own right, it is associated infrastructure. In all cases, the underground electrical line will follow the same route along the periphery of existing agricultural fields and avoid environmental sensitivities, with no biophysical impacts anticipated.

2. Water

The water required for the proposed development is available from within the existing approved water use allocations for the property. The property, which has been under cultivation for several decades, holds verified water abstraction and storage rights (refer to **Annexure B** below). A portion of the farm previously used for irrigation has been repurposed for the development of the existing poultry rearing facility. This shift in use ensures that the overall water consumption remains balanced and within the approved volumes. As such, sufficient water is available for the development without increasing total usage. The water that will sustain the new proposed chicken facility is registered under water use number 5 in water use register number 29017625, extract attached in Annexure B below. BOCMA has confirmed that a sector change will need to be undertaken for the water used within the poultry facilities. This is an administrative process that will be complied with.

3. Sewage

A conservancy tank system will be installed at the proposed development site as no wastewater treatment works is located nearby. The conservancy tank system will be serviced by the Theewaterskloof Local Municipality. Confirmation of service provision is provided in **Annexure C** below.

4. Poultry Facility Waste

Manure will be managed by directing a portion to the registered onsite composting facility. The remainder will be used directly in the agricultural industry onsite or sold to pre-determined buyers. High-pressure wash water will be used to clean the chicken houses, with any residual water lost through evaporation

Non-infectious mortalities will be disposed of via the registered onsite composting facility. The Applicant confirmed that there is sufficient composting capacity on the farm to accommodate the expected mortalities.

In the event of infected mortalities, these will be disposed of under the direct guidance of the State Veterinarian. The volumes associated with infected mortalities are small and do not pose any capacity concerns for licensed hazardous waste facilities. Should it be required Nunn 2 Waste will be able to accept and suitably dispose of hazardous waste from the facility (refer to Annexure D below).
