The Committee resolved to request the following further requirements:

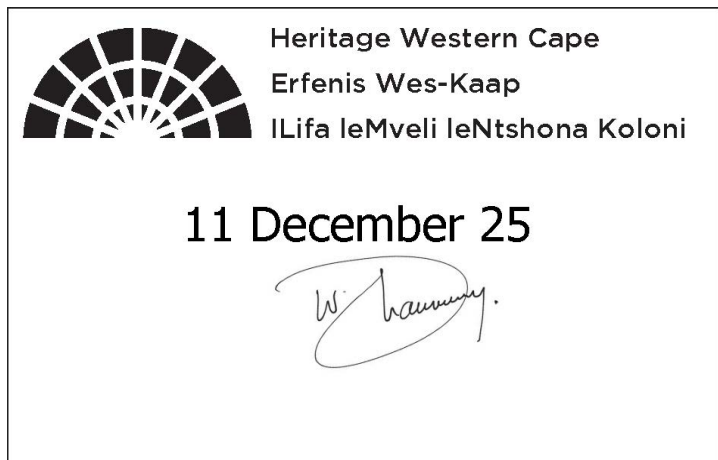

PERMIT

Site: Erf 24602, Haardekraaltjie Cemetery, Stellenbosch University, Parow


The application for proposed ground truthing on Erf 24602, Haardekraaltjie Cemetery, Stellenbosch University, Parow was tabled at the Impact Assessment Committee (IACOM) held on 3 December 2025

RECORD OF DECISION:

The Committee resolved to approve the proposed ground truthing as proposed in the application by Dr Orton, subject to the following conditions:

1. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used.
 2. A final report must be submitted to HWC within 30 days of practical completion
 3. Digital copies of all published papers, theses, or reports resulting from this work must be lodged with HWC.
 4. If a published report has not appeared within three years of the lapsing of this permit, the report in terms of the permit will be made available to researchers on request.
 5. It is the responsibility of the permit holder to obtain permission from the institution for each visit, and conditions of access imposed by the landowner must be observed.
 6. HWC shall not be liable for any losses, damage or injuries to persons or properties as a result of any activities in connection with this permit.
 7. HWC reserves the right to withdraw this permit by notice to the permit holder.
 8. The results of the survey be shared with interested and affected parties.
- This decision is subject to an **appeal period of 14 working days. Kindly note that the appeal period is calculated from the date indicated on the HWC date stamp, which is the date the appeal is sent, and not the date of signature**
 - Appeals to HWC are to be submitted to HWC.Appeals@westerncape.gov.za
 - The applicant is required to inform any party who has expressed a bona fide interest in any heritage-related aspect of this record of decision. The appeal period shall be taken from the date above. It should be noted that for an appeal to be deemed valid it must refer to the decision, it must be submitted by the due date, and it must set out the grounds of the appeal. Appeals must be addressed to the official named above and it is the responsibility of the appellant to confirm that the appeal has been received within the appeal period.
 - **Work may NOT be initiated during this 14-day appeal period.**
 - If any archaeological material or evidence of burials is discovered during earth-moving activities all works must be stopped and Heritage Western Cape must be notified immediately.
 - This approval does not exonerate the applicant from obtaining any necessary approval from any other applicable statutory authority.
 - **A copy of this permit must be displayed in a prominent place on the site until the permitted work is completed.**
