# **Appendix P: Confirmation of service provision**

### Water

Domestic water needs are anticipated to be basic and will be supplied from the existing borehole onsite. The taking of water from the borehole on site is considered a Schedule 1 usage and requires no authorisation under the NWA

## Electricity

The existing ESKOM electrical infrastructure will be used to supply electricity to the site, this will be supplemented with solar.

#### Waste

A conservancy tank will be installed onsite as approved within the existing Environmental Authorisation for the property (DEADP Ref. 16/3/3/1/E2/33/1059/23). The conservancy tank will be located adjacent to the existing access road for easy access. The conservancy tank will be serviced by a private contractor as indicated in the email communication (Email 1) below:

The local municipality was queried regarding the provision of solid waste services, and they confirmed that the service is not provided by OLM (Email 2). The landowner will make use of the closest transfer station for general and recyclable waste disposal which is located at the entrance to Pringle Bay (Figure 1).
